## **INSTRUCTIONS TO VOTERS**

There are four (4) propositions proposed for funding through a 1% Specific Purpose Sales and Use Tax. Each proposition stands alone. You may vote for or against each proposition. Each proposition must receive a majority of votes cast on that proposition to be approved.

Shall Laramie County be authorized to impose an additional one percent (1%) Specific Purpose Sales and Use Tax, within Laramie County, to be used and applied for funding the planning, engineering, construction, remodeling, furnishing, equipping, supplying (including maintenance equipment), acquistion and improvement of land (if necessary) and, to the extent necessary and allowed by law, the pledge to or payment of operation and maintenance, debt service and/or lease payments thereon, in the specified amounts and for the specified purposes provided below:

## **PROPOSITION 1**

To collect a total of \$9,661,000.00 and interest earned thereon for community enhancement and parks projects:

- A. \$2,800,000.00 to the City of Cheyenne for extension of the Cheyennne Greenway;
- B. \$750,000.00 to the City of Cheyenne for design and construction of the Cheyenne Botanical Gardens Conservatory;
- C. \$2,980,000.00 to Laramie County for a new Laramie County Shooting Sports Education Center to be built in the Archer Special Use District;
- D. \$300,000.00 to the Town of Burns to renovate and maintain the Burns Elementary School for use as a Multiple-Use Center;
- E. \$1,600,000.00 to the Town of Pine Bluffs to remodel and maintain the Pine Bluffs Community Center;
- F. \$855,000.00 to the Town of Pine Bluffs to construct and maintain a new Pine Bluffs Child Care Center at Reher Park;
- G. \$316,000.00 to the Town of Pine Bluffs to make improvements to the Pine Bluffs City Park and renovation of the Pine Bluffs Pool;
