



The Cheyenne/Laramie County EMS Joint Powers Board meeting was held in person at the Cheyenne/Laramie County EMA and via Zoom beginning at 1:30pm. Jeanine West began the meeting by welcoming everyone.

#### 1. Previous Meeting Minutes

Minutes for the March meeting were sent out prior to the meeting for the Boards' review. Chief Kopper made a motion to accept the minutes. Josh Van Vlack seconded the motion. All board members voted in favor.

#### 2. Finances

Chief Kopper provided the report with normal expenses and deposits for the month being made. No funding requests were received. He reported that Beth Harris will be sending out the proposed budget for the next meeting in June where we will have a public hearing for approval. Josh Van Vlack made a motion to accept the financial report. Titus Norris seconded the motion. All board members voted in favor.

#### 3. Monthly Reports

- a. Narva & Associates: Jeanine provided the report for Jon Narva who was called on for jury duty. She mentioned that due to issues with the CAD upgrade, there were some last minute data collecting for the reports which they were able to get all of the information. Jeanine noted that AMR was in compliance in all areas and that there were a couple of extended responses for the month. She reported that all of the certifications were received and were made available to Jeanine on a thumb drive. Dr. Schmitz thanked everyone for gathering the information and certifications were in the process of being reviewed. Jeanine noted that LCFD #4, LCFD #5 and Albin EMS were missing some of the certifications. They are working with these agencies for their certifications.
- b. AMR: Cody Schilling provided a review of the monthly report to the group which will be included with the minutes. Cody highlighted that although they were down on EMTs for staffing, it was because they passed their Paramedics licensing. MS154 is out of service and they are waiting on a new type 1 for this unit which is estimated to arrive in June. Cody reported that they had a meeting with the new management at the County Jail and discussed trainings and expectations for both entities. He also reviewed the data for the CAD data that was missing and added to the AMR report.

#### 4. Medical Directors

Dr. Schmitz provided his report. Albin EMS meeting included education with Bob Dean and they are also having a fundraiser which is open to everyone. Cody has volunteered to come out to Albin for run reviews. Pine Bluffs EMS had training and are doing very well. Dr. Schmitz met with AMR and CFR to discuss cardiac arrest cases. Brice and him interviewed a new paramedic for CFR.

#### 5. CRMC

Jared reported that the helipad has been dismantled and are starting the reconstruction. At this time there is not definite timeline for the repairs.

#### 6. LifeLine

Not in attendance.

#### 7. <u>Dispatch</u>

Amber Young thanked everyone for their support for Telecommunicators Week. She reported that there were 12,101 calls for service with 1,313 EMS calls for service. Amber added that they had 5 applicants, but are down to two. They are working on radio refresher training and if anyone is interested to let her know.

#### 8. FE Warren AFB/VA Medical Center

Not in attendance.

#### 9. Cheyenne Fire Rescue

Chief Kopper reported that the stations are open and working on the CAD. They are going through the budget and are down 3 positions due to retirements.

#### 10. County Fire Districts

Josh Van Vlack reported that LCFA is still moving through their EMT class and spring academy will graduate this month. LCFA has case reviews scheduled for June 27<sup>th</sup>.

#### 11. Information Technology

Samuel Walker reported that one of the lines in dispatch are down and hope to have it working before CFD.

#### 12. Old Business

a. ImageTrend: Jeanine stated that at the last meeting the Board was asked to send a letter to the State EMS about the issues the agencies are experiencing. Contact was made from the State and was directed to talk with Josh Van Vlack. Josh reported that the current version is the short form but the State is open to discussion on how it can be improved. Josh will followup with the State and possibly have them come to the Fire Chiefs Association meeting or the next EMS JPB.

#### 13. New Business

No new business.

The meeting was adjourned at 1:57pm.
